## Contract Agreement

WHEREAS, the Entity invited Bids for the *Procurement of 6 Sets Pump Irrigation System and Water Pump with Hose Adaptor* and has accepted a Bid by the Supplier for the sum of *Four Hundred Seventy Nine Thousand Four Hundred Pesos Only (Php479, 400.00)*. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

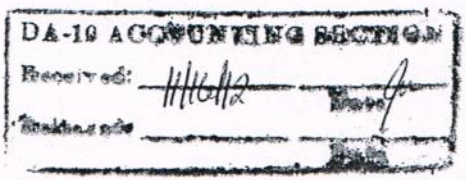
1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contracts hereinafter referred to.
