WHEREAS, the Department of Agriculture advertised the Invitation to Bid for the Procurement of 3 units Rehabilitation and Retrofitting of Biomass Furnace to Existing Recirculating Mechanical Dryer with Approved Budget for the Contract of Php1,725,000.00, posted/published the same in the Department of Agriculture website, Phil-GEPS and a conspicuous place of the Department of Agriculture continuously for 7 days;

WHEREAS, three (3) units Rehabilitation and Retrofitting of Biomass Furnace to Existing Recirculating Mechanical Dryer would have a Counterpart of 85% DA Equity- 15% Proponent Equity;

WHEREAS, no prospective bidder responded the said advertisement and participated the Pre-bid conference on September 13, 2012, 9:00 AM @ BAC Office;

WHEREAS, only Suki Trading Corporation of Agus, Ibabaw, Lapu-lapu City present during the Submission and Checking of Eligibility Documents and Opening of Bid was conducted last September 25, 2012 at 9:00 AM @ BAC Office, thus declared "ELIGIBLE";

WHEREAS, the bid proposal of Suki Trading Corporation was found to be substantially complying;

- b) To recommend the "AWARD" for approval of Regional Executive Director of the abovementioned procurement.






