INVITATION TO BID UNDER NEGOTIATED PROCUREMENT

The Department of Agriculture – Regional Office 10, through the **AgriPINOY Livestock Program** intends to apply the sum of **One Million Two Hundred Fifty Thousand Pesos (Php1,250,000.00)** being the Total Approved Budget for the Contract (ABC) to payment under the contract for **Various Animals.**

- > All animals should be apparently healthy and free from any physical abnormalities and defects
- > Required vaccination certification from a licensed veterinarian for Chicken, Swine and Cattle.
- Mortalities within three (3) days after delivery should be replaced within (1) week as long as the mortalities are not due to negligence on the part of the recipients
- Delivery of the Goods is required within <u>Sixty (60)</u> calendar days upon the receipt of the Notice to Proceed, directly to the <u>recipients of Cabanglasan</u>, <u>Sapang Dalaga and Pantar</u>.

The Department of Agriculture – Regional Office 10 now invites **PRODUCERS/DEALERS/HANDLERS** through "**PARTIAL BIDS**" for the Procurement of Various Animals.

Delivery of the Goods is required within <u>Sixty (60)</u> calendar days upon the receipt of the Notice to Proceed, directly to the <u>recepients of Cabanglasan</u>, <u>Sapang Dalaga and Pantar</u>.

Bidders should have completed, within *5 years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through **negotiated procurement** following procedures as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Department of Agriculture – Regional Office 10 and inspect the Bidding Documents at the address given below during **8:30AM to 5:00 P.M., Monday to Friday**.

The Department of Agriculture – Regional Office 10 will hold a <u>Pre-bid Conference on Dec. 6, 2013 at 1:30 in the afernoon</u> at Bids and Awards Committee Office, which shall be opened only to all interested parties.

Bids Opening shall be on <u>December 13, 2013 at 1:30 in the afternoon</u> at Bids and Awards Committee Conference Room. Bids will be opened in the presence of the Bidders or Bidders' authorized representatives .Late bids shall not be accepted.

The Department of Agriculture – Regional Office 10 reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
