WHEREAS, the Department of Agriculture has a Purchase Request of **Procurement of 300 Bags Upland Rice Seeds** with an Approved Budget for the Contract (ABC) of **Three Hundred Thousand Pesos & 00/00 (Php300,000.00)**;
