

CATERING AND ACCOMMODATION SERVICES AGREEMENT

KNOW ALL MEN BY THESE PRESENTS :

This CONTRACT is entered into by and between :

The Department of Agriculture, Regional Field Office No. 10 (DA-RFO-10), represented by its Regional Director **LEALYN A. RAMOS**, of legal age, with office address at Antonio Luna St., Cagayan de Oro City, and represented by its Assistant Regional Director, hereinafter called the FIRST PARTY;

WITNESSETH
