**BAC Resolution No 1535, series of 2015**

WHEREAS, the Department of Agriculture has a Purchase Request for the **Procurement of Various Fertilizers** with an Approved Budget for the Contract (ABC) of **Fifty Nine Thousand Seven Hundred Pesos & 00/100 (Php59, 700.00)**;




