

CATERING SERVICES AGREEMENT

KNOW ALL MEN BY THESE PRESENTS :

This CONTRACT is entered into by and between :

The Department of Agriculture, Regional Field Office No. 10 (DA-RFO-10), represented by its Regional Director **LEALYN A. RAMOS**, of legal age, married with office address at Antonio Luna St., Cagayan de Oro City, and represented by its Assistant Regional Director, hereinafter called the FIRST PARTY;

CRYSTAL INN, represented by LORETO UY SEMAÑA of legal age, and a resident of GEORGE SHEKER PARADE, SAN MIGUEL, ILIGAN CITY, hereinafter called the SECOND PARTY;

W I T N E S S E T H

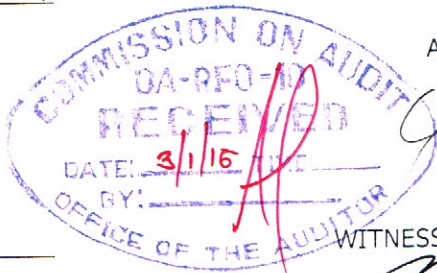
