WHEREAS, the Department of Agriculture has a Purchase Request on **Labor and Materials for the Construction of Concrete Fence (80 m. length and 1.5 m. height) at RCUD, Barongcot, Danggagan, Bukidnon (Phase 1)** with an Approved Budget for the Contract (ABC) **Two Hundred Thousand Pesos 00/00 (Php200,000.00)**;
