WITNESSETH

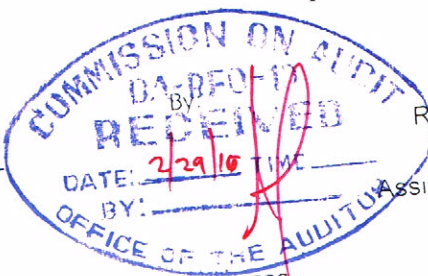

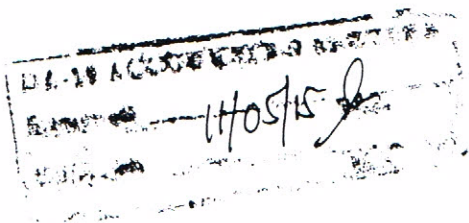
