WHEREAS, the Department of Agriculture has a Purchase Request for the 16 spot Airtime contract for 1 minutes Corn TC plugs good for 16 telecasts in NM to start in July 2016; TV Station should meet the following specs: It must be a commercial TV Station & already in business operation for more than 5 years; It must be a national in scope & can be viewed in major cities in Mindanao; Freq.-3x a day at primetime every MWF; submit latest NTC permit to operate & other legal docs with an Approved Budget for the Contract (ABC) of One Hundred Forty Four Thousand Pesos & 00/00 (Php144, 000.00);
