THIS AGREEMENT made the 17th day of ~~FEBRUARY~~ 2017 between **Department of Agriculture, Regional Field Office-10, Antonio Luna Street, Cagayan de Oro City of the Philippines** (hereinafter called "the Entity") of the one part and **FORTUNETRACT AGRO-SALES INC., J.P.
