WHEREAS, the Department of Agriculture advertised the Invitation to Bid with ITB Reference No. 2016-075/ACN for the **SUPPLY AND DELIVERY OF VARIOUS AGRI-MACHINERIES** with its subsequent Approved Budget for the Contract and posted the same in Manila Bulletin newspaper, Department of Agriculture website, Phil-GEPS and a conspicuous place of the Department of Agriculture continuously for 7 days to wit;

WHEREAS, DP Fabrication & Machineries, Filholland Corp., Fortunetract Agro-Sales Inc., Ford Tractor Phils. Inc., and Suki Trading Corporation participated the Pre-Bid Conference on **December 6, 2016, 9:00AM** at the BAC Conference Room, DA-10 Regional Office;

WHEREAS, during the Submission and Checking of Eligibility Documents and Opening of Bids conducted last **December 19, 2016 at 3:30 PM** at BAC Conference Room, Fortunetract Agro-Sales Inc., Megamight Enterprises, P.I. Farms Inc., Suki Trading Corporation and Super Trade Enterprises submitted their bids for the following lots:

- Fortunetract Agro-Sales Inc. - 2, 4 & 5
- Megamight Enterprises - 2, 3, 4 & 5
- P.I. Farms Inc. - 1, 4 & 5
- Suki Trading Corporation - 2, 4 & 5
- Super Trade Enterprises - 1

WHEREAS, the committee declared Fortunetract Agro-Sales Inc., Megamight Enterprises, Suki Trading Corporation and P.I. Farms (for Bid Lot 4 only) as **ELIGIBLE BIDDERS**;

WHEREAS, the following bidders were declared **"INELIGIBLE"** to bid for the following reasons:

1. **P.I. FARM PRODUCTS INC. for Bid Lot 1 and 5**
 - a. Failure to attach the supporting documents for SF-GOODS 13b Statement of Bidder's Single Largest Government & Private Contract completed which is similar in nature in **Bid Lot 1**.
 - b. Inconsistent figure/amount indicated in the Official Receipt versus SF-GOODS 13b Statement of Bidder's Single

Largest Government & Private Contract completed which is similar in nature in **Bid Lot 5**.

2. SUPER TRADE ENTERPRISES

Failure to indicate the amount of the Similar Contract in the Official Receipt as supporting document on the SF-GOODS 13b Statement of Bidder's Single Largest Government & Private Contract completed which is similar in nature.

WHEREAS, P.I. FARM PRODUCTS INC. and SUPER TRADE ENTERPRISES were given 3 working days to submit a motion for reconsideration together with the required supporting documents;

WHEREAS, P.I. FARM PRODUCTS INC. and SUPER TRADE ENTERPRISES submitted their Motion for Reconsideration together with the required supporting documents and deliberation of their motion was held on December 27, 2016 at the BAC Conference Room wherein said motion were reconsidered and approved. Furthermore, Continuation of Opening of Bids was scheduled on December 29, 2016;

WHEREAS, during the continuation of the Opening of Bids conducted last **December 29, 2016 at 10:30 AM** @ the BAC Office, P.I. FARM PRODUCTS INC. and SUPER TRADE ENTERPRISES were declared **ELIGIBLE BIDDERS**;



- b) To recommend the AWARD for approval of CARLENE C. COLLADO, OIC, Regional Director of the Department of Agriculture, RFO-10.




