**BAC RESOLUTION NO. 91-2017-A, SERIES OF 2017,
SINGLE CALCULATED RESPONSIVE BID (SLCRB)
AND RECOMMENDING APPROVAL**

WHEREAS, the Department of Agriculture advertised the Invitation to Bid with IB No. 2017-083/SQD for the Labor and Materials of Bid Lot 1 - 7 units Spring Development at Bukidnon, Bid Lot 2 - 4 units Spring Development at Lanao del Norte, Bid Lot 3 - 6 units Spring Development at Misamis Occidental, Bid Lot 4 - 3 units Spring Development at Misamis Oriental with Approved Budget for the Contract of Bid Lot 1 - FOUR MILLION TWO HUNDRED THOUSAND PESOS (Php 4,200,000.00), Bid Lot 2 - TWO MILLION FOUR HUNDRED THOUSAND PESOS (Php 2,400,000.00), Bid Lot 3 - THREE MILLION SIX HUNDRED THOUSAND PESOS (Php 3,600,000.00), and Bid Lot 4 - ONE MILLION EIGHT HUNDRED THOUSAND PESOS (Php 1,800,000.00) and posted the same in Department of Agriculture website, Phil-GEPS and a conspicuous place of the Department of Agriculture on October 12, 2017 to November 3, 2017;

WHEREAS, in response to the said advertisement, only **GHS Construction and Development Services of Blk 57, Lot 3, Bloomingdale, Iponan, Cagayan de Oro City**, bought the bidding documents and attended the Pre-bid Conference on **October 20, 2017, 9:00AM @ BAC Conference Room, DA-10 Regional Office**;

WHEREAS, Submission and Opening of Bids conducted on **November 3, 9:00AM** at BAC Office, **GHS Construction and Development Services** was declared **ELIGIBLE AND COMPLYING BIDDER**;

WHEREAS, the bid proposal of **GHS Construction and Development Services** was found to be substantially complying;

WHEREAS, upon validation and verification of all legal, technical and financial requirements submitted by the Bidder with Single Calculated Responsive Bid and deliberation of Post Qualification Report by the Bids and Awards Committee and the Technical Working Group, GHS Construction and Development Services, its bid have been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare GHS Construction and Development Services as the Bidder with SINGLE CALCULATED RESPONSIVE BID for the Labor and Materials of Bid Lot 1 - 7 units Spring Development at Bukidnon, Bid Lot 2 - 4 units Spring Development at Lanao del Norte, Bid Lot 3 - 6 units Spring Development at Mis. Occidental, Bid Lot 4 - 3 units of Spring Development at Misamis Oriental with contract price of Bid Lot 1 - FOUR MILLION ONE HUNDRED EIGHTY TWO THOUSAND SIX HUNDRED EIGHTY TWO PESOS AND 54/00 (Php 4,182,682.54) , Bid Lot 2 - TWO MILLION THREE HUNDRED NINETY THOUSAND ONE HUNDRED FOUR PESOS AND 31/00 (Php 2,390,104.31), Bid Lot 3 - THREE MILLION FIVE HUNDRED EIGHTY FIVE THOUSAND ONE HUNDRED FIFTY SIX PESOS AND 46/00 (Php 3,585,156.46), and Bid Lot 4 - ONE MILLION SEVEN HUNDRED NINETY TWO THOUSAND FIVE HUNDRED SEVENTY EIGHT PESOS AND 23/00 (Php 1,792,578.23).
- b) To recommend the AWARD for approval of CARLENE C. COLLADO, OIC, Regional Director of the Department of Agriculture, RFO-10 for the foregoing findings.
