

Contract Agreement

THIS AGREEMENT made the 14th day of December 2017 between Department of Agriculture, Regional Field Office-10, Antonio Luna Street, Cagayan de Oro City of the Philippines (hereinafter called "the Entity") of the one part and JEDECO TRADING CORPORATION, 16 Del Pilar St., Vigan City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of 1,241 bags Certified OPV White Corn Seeds - Bid Lot-2** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION EIGHT HUNDRED THIRTY SIX THOUSAND SIX HUNDRED EIGHTY PESOS (Php1,836,680.00)**, (hereinafter called "the Contract Price") to be delivered within **Sixty (60)** calendar days with the following specifications:

Certified OPV White Corn Seeds , 20 kg. per bag, not more than 14% moisture content, not less than 85% germination, Passed NSQCS/Tagged and Sealed, Sacks marked with DA RFO 10 SAAD Program and NOT FOR SALE

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
