

Contract Agreement

THIS AGREEMENT made the 29th day of December 2017 between **Department of Agriculture, Regional Field Office - 10**, Antonio Luna Street, Cagayan de Oro City of the Philippines (hereinafter called "the Entity") of the one part and **JEC EQUIPMENT TRADING & SERVICES**, Purok Falcata Hills, Barangay Tubod, Iligan City of the Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of 5 units Double Cab Dropside -Light Cargo Truck (Brand New)** under Rice, Corn and Livestock Program Funds and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Six Million Five Hundred Thousand Pesos (Php6,500,000.00)** (hereinafter called "the Contract Price"). Delivery period is within **60 calendar days** with the following specifications:

5 UNITS - KIA K2500 D.C. 4X4 EURO 4 (COLOR: WHITE)

- Displacement: 2,497 cc but not exceeding 7,000cc
- Transmission: 5- speed manual
- Drive train: 4WD
- Engine Type: Turbo Charger Inter-Cooler Fuel: Diesel
- Suspension: Front: Torsion Bar spring with Stabilizer
- Rear: Multi-leaf spring
- 4 - 6 wheel light truck with open/ dropside cargo hold

Terms and Conditions:

- Accredited service center within Region 10
- 3 years (100,000 km) warranty
- 3 years LTO Registration
- TPL insurance
- With Operators' Manual & Brochure

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. Bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Entity's Notification of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
