WHEREAS, the Department of Agriculture advertised the Invitation to Bid with **IB No. 2017-087/BRPB** for the **Labor and Materials for the Construction of 1 UNIT Warehouse at Butig, Lanao del Sur** with Approved Budget for the Contract of **FOUR MILLION FIVE HUNDRED THOUSAND PESOS AND 00/100 (Php 4, 500,000.00)** and posted the same in Department of Agriculture website, Phil-GEPS and a conspicuous place of the Department of Agriculture on November 7, 2017 to November 29, 2017;

WHEREAS, only **NASIACOM BUILDERS** of **Quezon Avenue, Banggolo, Marawi City, Lanao del Sur / 003 Villarafael Subd., Tubod, Iligan City** bought the bidding documents and attended the Pre-bid Conference on **November 17, 2017, 9:00AM @ BAC Conference Room, DA-10 Regional Office**;

WHEREAS, Submission and Opening of Bids conducted on **November 29, 2017, 9:00AM** at BAC Office, **NASIACOM BUILDERS** was declared **ELIGIBLE AND COMPLYING BIDDER**;

WHEREAS, the bid proposal of **NASIACOM BUILDERS** was found to be substantially complying;

WHEREAS, during the bid evaluation conducted by the Bids and Awards Committee and Technical Working Group, the Total Bid as Calculated is **FOUR MILLION FOUR HUNDRED NINETY EIGHT THOUSAND EIGHT HUNDRED TEN PESOS AND 21/100 (Php 4, 498,810.21)**.which is lower than the Total Bid as Read of **FOUR MILLION FOUR HUNDRED NINETY EIGHT THOUSAND EIGHT HUNDRED TEN PESOS AND 19/100 (Php 4, 498,810.19)**.

WHEREAS, conflict on arithmetical computation between "Bid as Read" and "Bid as Calculated" of which the lower figures will prevail;

WHEREAS, Total Bid as Calculated of **FOUR MILLION FOUR HUNDRED NINETY EIGHT THOUSAND EIGHT HUNDRED TEN PESOS AND 19/100 (Php 4, 498,810.19)**.is the contract price since this is advantageous to the government;


WHEREAS, upon validation and verification of all legal, technical and financial requirements submitted by the Bidder with Single Lowest Calculated Responsive Bid and deliberation of Post Qualification Report by the Bids and Awards Committee and the Technical Working Group, **NASIACOM BUILDERS**, its bid have been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


