**CONTRACT AGREEMENT**

**THIS AGREEMENT** made the 29<sup>th</sup> day of Dec 2017 between **DEPARTMENT OF AGRICULTURE, Regional Field Office No. 10, Antonio Luna Street, Cagayan de Oro City of the Philippines** (here in after called "the Entity") of the one part and **MJL LIVESTOCK DEALER, Purok 2, Lumbo, Valencia City, Bukidnon.** (here in after called "the Supplier") of the other part;

(e) the Special Conditions of Contract;


(f) the Performance Security; and

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


