**BAC Resolution No. 101-2017A series of 2017,
 DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB)
 AND RECOMMENDING AWARD FOR APPROVAL**

WHEREAS, the Department of Agriculture Regional Field Office 10 advertised the Invitation to Bid with IB Reference No. 2017-090/JDM for the SUPPLY AND DELIVERY OF VARIOUS ANIMALS, **Bid lot 1 - 45 Head Cattle-Upgraded Male & 150 Head Cattle-Upgraded Female and Bid lot 3 - 20 Head Carabao-Upgraded & 13 Head Carabao-Upgraded Male** with an Approved Budget for the Contract of Five Million Eight Hundred Fifty Thousand Pesos (Php5,850,000.00) and Nine Hundred Ninety Thousand Pesos (Php990,000.00), respectively, posted the same in the PhilGeps, Department of Agriculture website and a conspicuous place at the Department of Agriculture RFO10 continuously on November 9 to 29, 2017;

WHEREAS, in response to the said advertisement, MJL Livestock Dealer, BMA Livestock Dealer, RM Livestock Buy & Sell, all from Valencia City, Bukidnon, Julimon's Enterprises of Iligan City and Tommy's Hogs and Cattle of El Salvador City attended the Pre-bidding Conference on November 17, 2017, 1:00PM at BAC Conference room;

WHEREAS, only MJL Livestock Dealer and BMA Livestock Dealer submitted bid proposal for Bid lot 1 and Bid lot 3;

WHEREAS, opening of bids was conducted on November 29, 2017 2:30PM at BAC conference room, **MJL Livestock Dealer** was declared **ELIGIBLE AND COMPLYING BIDDER**, while **BMA Livestock Dealer** was declared **INELIGIBLE BIDDER** for having failed to indicate the delivery period in Section VI. Schedule of Requirements;

WHEREAS, the bid proposal of MJL Livestock Dealer was found to be substantially complying;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:




b) To recommend the **AWARD** for approval of the **Regional Director** of the **Department of Agriculture RFO - 10** for the forgoing findings.




