THIS AGREEMENT made the 29 day of Dec. 2017 between **DEPARTMENT OF AGRICULTURE, Regional Field Office No. 10, Antonio Luna Street, Cagayan de Oro City of the Philippines** (here in after called "the Entity") of the one part and **TOMMY'S HOGS & CATTLE, Zone 3, Cogon, El Salvador City, Misamis Oriental.** (here in after called "the Supplier") of the other part;

- (f) the Performance Security; and
- (g) the Entity's Notification of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.






