WHEREAS, the Department of Agriculture has a Purchase Request on Provision of Food and Accommodation for the conduct of Various Regulatory Activities with an Approved Budget for the Contract (ABC) of Six Hundred Thirty Six Thousand One Hundred Ninety Nine Pesos & 70/100 (Php 636,199.70);

WHEREAS, there is a need to enter into a negotiated procurement under Small Value Procurement considering that the Approved Budget of the contract is below the threshold level of One Million Pesos & 00/00 (Php1,000,000.00) as provided under Section 53.9 of the revised implementing rules and regulations;

WHEREAS, said Procurement was posted in PhilGeps/Agency website on March 8, 2017;

WHEREAS, TIEZA-GARDENS OF MALASAG ECO TOURISM, DepED R-X CONSUMER'S COOP, AND CHALI BEACH AND RESORT CORPORATION only responded to the Request for Quotation with the following bid offer/specifications;




