 SINGLE CALCULATED RESPONSIVE BID
 AND RECOMMENDING AWARD FOR APPROVAL**

WHEREAS, the Department of Agriculture RFO 10 advertised the Invitation to Bid with ITB Reference No. 2018-075/ACN for the **Labor, Equipment and Materials for the Construction of Spring Development for Brgy. Bisigan, Cagayan de Oro City, and Brgy. Santiago, Gingoog City, Misamis Oriental** with an Approved Budget for the Contract (ABC) of Php1,750,000.00, under HVCDP Funds, and posted the same in PhilGEPS, DA RFO 10 website, and conspicuous place at the premises of the Department of Agriculture RFO 10 continuously from July 12 – August 1, 2018;

WHEREAS, BARKADAHAN YOUNG BUILDERS, INC. and JM LACORTE CONSTRUCTION represented by Mr. Elfer James Mangadlao and Mr. Antonio Maxilom respectively, responded the said advertisement and participated the Pre-Bid Conference on **July 20, 2018, 1:00pm** at the BAC Office, DA Regional Field Office 10;

WHEREAS, only **BARKADAHAN YOUNG BUILDERS, INC.** bought the bidding documents and submitted bid proposal for the said procurement;

WHEREAS, Submission and Opening of Bids was conducted on August 1, 2018, 1:00pm and declared **BARKADAHAN YOUNG BUILDERS, INC.** as **Eligible and Complying Bidder**;

WHEREAS, the bid proposal of **BARKADAHAN YOUNG BUILDERS, INC.** was found to be substantially complying;


