Contract Agreement CoA-2018-0049

THIS AGREEMENT made the 3rd day of SEPTEMBER 2018 between **Department of Agriculture, Regional Field Office - 10**, Antonio Luna Street, Cagayan de Oro City of the Philippines hereinafter called "the Entity" of the one part and **JULIMONS ENTERPRISES**, Iligan City, hereinafter called "the Supplier" of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Various Animals (Bid Lot 1)** under Livestock Program and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Seven Hundred Eighteen Thousand Five Hundred Pesos (Php3,718,500.00)**, hereinafter called "the Contract Price". Delivery period is within **120 calendar days** with the following specifications:

Terms and Condition:

1. Mortalities within one week after the delivery should be replaced within three (3) days as long as the mortalities are not due to negligence on the part of the recipients.
2. Two (2) weeks observation period after selection prior to delivery for the small ruminants.
3. Animals for selection should be replaced in consolidation area for selection, blood sample collection, ear tagging and for observation period prior to the delivery.
4. Cost of laboratory test and ear tag will be shouldered by the supplier. ALL animals will be subjected to blood sample collection for laboratory testing but only 20% of the sample will be paid by the supplier.
5. Notice of selection/Delivery shall be submitted and received by the office at least 2 weeks before the schedule.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) the Bid Form and the Price Schedule submitted by the Bidder;
- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the Special Conditions of Contract; and
- (e) the Entity's Notification of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.


4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
