WHEREAS, the Entity is desirous that the Contractor execute for **Labor and Materials for the 300 units Chicken Layer Cage and Establishment of 300 units Poultry Shed**, hereinafter called "**the Works**" and the Entity has accepted the Contract Price of **Twelve Million Six Hundred Twenty-Four Thousand Eighty-Nine Pesos & 4/00 (Php12,624,089.04)** by the Contractor for the execution and completion of such Works is within **Forty-Five (45)** calendar days and the remedying of any defects therein. Project Location is at **Municipalities of Lanao del Sur: Kapai, Piagapo, Bubong, Bayang, Lumbatan and Marawi City**. Scope of Work are as follows:

 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/ or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.






