WHEREAS, in response to the said advertisement, Cagayan Educational Supply of Daumar-Mortola Hayes Sts., Cagayan de Oro City, attended the Pre-bid Conference on August 13, 2018, 10:30AM at BAC Conference Room;

WHEREAS, Submission and Opening of Bids was conducted on August 29, 2018, 9:30AM at BAC Conference Room, Cagayan Educational Supply of Daumar-Mortola Hayes Sts., Cagayan de Oro City and MC Paper Smart Marketing Inc. of Pabayo-Yacapin Sts. Cagayan de Oro submitted bid proposal.

WHEREAS, Cagayan Educational Supply was declared Eligible and Complying bidder while MC Paper Smart Marketing Inc. was declared Ineligible due to lacking attachment of SF13b-Statement of Single largest completed Contract, failure to attach the computation of NFCC and inappropriate filling-up of Section VI. Schedule of Requirements & Section VII. Technical specification.

WHEREAS, the bid proposal of Cagayan Educational Supply was found to be substantially complying;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED:


