WHEREAS, **Clarenzon Marketing** was declared non-complying/non-responsive bid for having quoted incomplete bid;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:






