- 2. Delivery Period : within **Sixty** (60) calendar days
- 3. The period for correction of defects in the warranty period is one (1) week

4. Special Condition of the Contract:

- BAI accreditation permits
- Mortalities within one week after the delivery should be replaced within three (3) days as long as the mortalities are not due to negligence on the part of recipients
- Two weeks observation period after selection prior to delivery
- Animals for selection should be placed in consolidation area for selection, blood sample collection, ear tagging and for observation period to delivery
- In every selection period, a total of 20% of the animal population will be subjected to blood sample collection for laboratory testing and ear tagging will be paid by the supplier

- Notice of selection / delivery shall be submitted and received by the office at least 2 weeks before the schedule
- Vaccination and deworming must be specified in the certification signed by the licensed veterinarian
