**BAC RESOLUTION NO. IS- 057- 2019A, SERIES OF 2019,  
DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB)  
AND RECOMMENDING THE AWARD FOR APPROVAL**

**WHEREAS**, the Department of Agriculture Regional Field Office 10 (DA RFO 10) posted the Invitation to Bid with Reference No.: **IB No. 2019-065/MAPF** for the **Labor, Equipment and Materials for the Construction of 10 Units Nursery Establishment** with Approved Budget for the Contract (ABC) of **Five Million Pesos Only (P 5,000,000.00)** in the PhilGEPS website, DA RFO 10 website and a conspicuous place of the DA RFO 10 on March 6 – 26, 2019;

**WHEREAS**, in response to the said posting, **NETAPHILS, INC.** bought the bidding documents and attended the Pre-bid Conference on **March 14, 2019, 9:30 AM** at the Bids and Awards Committee (BAC) Office, DA RFO 10, Antonio Luna St., Cagayan de Oro City;

**WHEREAS**, **Notice of Postponement** on March 19, 2019 was issued to reschedule the deadline of the submission of bids and opening of bids from March 26, 2019, 8:30am and 9:00am, to **April 1, 2019, 12:30pm and 1:00pm** respectively;

**WHEREAS**, **NETAPHILS, INC.** submitted its bid proposal before the deadline of Submission of Bids on **April 1, 2019, 12:30 PM**;

**WHEREAS**, during the conduct of Opening of Bids on **April 1, 2019, 1:00 PM** at the BAC Office, the lone bidder **NETAPHILS, INC.** was declared **ELIGIBLE BIDDER**;

**WHEREAS**, the bid proposal of **NETAPHILS, INC.** was found to be substantially complying;

**WHEREAS**, detailed evaluation of bids conducted on **April 5, 2019, 10:00AM** at BAC Office resulted the following:

**WHEREAS**, upon validation and verification of all legal, technical and financial requirements submitted by **NETAPHILS, INC.** with the Single Calculated Bid and the deliberation of Post Qualification Report by the Bids and Awards Committee - Technical Working Group, its bid was found to be **RESPONSIVE**;

**WHEREAS**, Section 34.4 of the IRR of RA 9184 dictates that if the BAC determines that the bidder with the Single Calculated Bid passes all the criteria for post-qualification, it shall declare the bid as the Single Calculated and Responsive Bid at its submitted bid price or its calculated bid prices, whichever is lower, in this case the Bid as Calculated amounting to **Php 4,385,255.00**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a. To declare the bid of **NETAPHILS, INC.** as the **SINGLE CALCULATED AND RESPONSIVE BID (SCRB)** for the **Labor, Equipment and Materials** for the **Construction of 10 Units Nursery Establishment** with contract price of **FOUR MILLION THREE HUNDRED EIGHTY-FIVE THOUSAND TWO HUNDRED FIFTY-FIVE PESOS ONLY (Php 4,385,255.00)**.
- b) To recommend the **AWARD** for approval of **CARLENE C. COLLADO, OIC**, Regional Executive Director of the Department of Agriculture, **RFO-10** for the foregoing findings.




