**WHEREAS**, invitations for negotiation meeting were sent to **BQPC Corporation, JMG Construction & General Merchandise** and **L & L Construction;**

**WHEREAS**, **BQPC Corporation, JMG Construction & General Merchandise** and **L and L Construction** participated the Negotiated Meeting conducted on **October 30, 2019, 10:00am** at the Bids and Awards Committee Office, DA RFO 10, Antonio Luna St., Cagayan de Oro City;

**WHEREAS**, **JMG CONSTRUCTION & GENERAL MERCHANDISE** and **L & L CONSTRUCTION** submitted their bid proposals before the deadline of submission on **November 4, 2019, 9:30am;**

**WHEREAS**, on the Opening of Bids conducted on November 4, 2019, 9:30am, the committee declared **JMG CONSTRUCTION & GENERAL MERCHANDISE** and **L&L CONSTRUCTION ELIGIBLE and COMPLYING BIDDERS;**

**WHEREAS**, the bid proposals of **JMG CONSTRUCTION & GENERAL MERCHANDISE** and **L&L CONSTRUCTION** were found to be substantially complying:


