We are pleased to notify you that your Bid dated January 22, 2020 for the Supply and Delivery of 70,000 pcs. Cacao Certified Seedlings (w/tag) - UF 18 Variety and 70,000 pcs. Cacao Certified Seedlings (w/tag) - BR 25 Variety, Bid Lot 1 with a contract price of Three Million Four Hundred Nine Thousand Pesos (Php3,409,000.00) is hereby accepted and AWARDED to your firm with the following specifications;

- Asexually propagated
- Clone / Variety:
  - 70,000 pcs. UF 18 variety
  - 70,000 pcs. BR 25 variety
- Must be planted in at least 15.24 x 25.4 x .0076 cm (6x10x0.003 in) black polyethylene bag
- Must be at least 60 - 100 cm from the soil line
- Graft/ bud union must be 30- 40 cm. from the soil line and fully healed with no plastic wrap
- Must have at least 6 matured leaves
- Should have no symptoms of Vascular Streak Dieback (VSD) and pest damage/ injury to the leaves should be <10% of the total area of each leaf; and
- No parts of the root system must be exposed outside the black polyethylene and not root bounded.
- Soil media: Loam
- Ready to plant when delivered
- Acclimatized and hardened (leaves)
- Inclusive of 12 days rearing of delivered seedlings per delivery site
- During delivery seedlings must be on wooden crate (15- 20 seedlings per crate)


