**WHEREAS**, the Department of Agriculture advertised the Invitation to Bid with IB Reference No. 2020-012/JRT for the Supply and Delivery of 70,000 pcs. Cacao Certified Seedlings (w/tag) - UF 18 Variety and 70,000 pcs. Cacao Certified Seedlings (w/tag) - BR 25 Variety, Bid Lot 1 under HVCDP with an Approved Budget for the Contract of Four Million Nine Hundred Thousand Pesos (4,900,000.00) and posted the same in Department of Agriculture website, Phil-GEPS and a conspicuous place of the Department of Agriculture continuously from January 2-22, 2020;

**WHEREAS**, in response to the said advertisement, there were eleven (11) Prospective Bidders attended the Pre-Bid Conference on January 10, 2020, 2:30 PM at Harbor Lights Hotel, Gusa, Cagayan de Oro City, to wit;

**WHEREAS**, Opening of Bids was conducted on January 22, 2020, at DA 10 BAC Office, A. Luna St., Cagayan de Oro City, only five (5) bidders submitted their bid proposals to wit;

**WHEREAS**, Dayot Plant Nursery, PELF Plant Nursery and St. Padre Pios Garden were declared eligible and complying bidders while Binahon Agro Forestry Farm and Popoy's Plant Nursery were declared ineligible bidders due to failure to submit valid Tax Clearance and failure to submit 2017 Audited Financial Statement respectively;

**WHEREAS**, the bid proposals of Dayot Plant Nursery, PELF Plant Nursery and St. Padre Pios Garden were found to be substantially complying, hence their financial bids were read by the Chairperson, as follows;
