SINGLE CALCULATED RESPONSIVE BID (SCRB)  
AND RECOMMENDING APPROVAL**

**WHEREAS**, the Department of Agriculture advertised the Invitation to Bid with IB No. 2020-014/JRT for the Supply and Delivery of 3 units High Pressure Vehicle Automatic Sprayer under LIVESTOCK PROGRAM with an Approved Budget for the Contract of Four Million Eight Hundred Thousand Pesos (4,800,000.00) and posted the same in Department of Agriculture website, Phil-GEPS and a conspicuous place of the Department of Agriculture continuously from January 25- February 14, 2020;

**WHEREAS**, Shock and Awe Trading of Davao City and Julimon's Enterprises of Iligan City participated the Pre-Bid Conference on February 03, 2020, 10:00 AM at the BAC Conference Room, DA-10 Regional Office;

**WHEREAS**, Opening of Bids was conducted on February 14, 2020, 3:30 PM at DA 10 BAC Office, A. Luna St., Cagayan de Oro City, Shock and Awe Trading and Julimon's Enterprises submitted their bid proposals;

**WHEREAS**, Julimon's Enterprises was declared Eligible and Complying bidder while Shock and Awe Trading was declared ineligible due to the absence of DTI Registration Certificate.

**WHEREAS**, Shock and Awe Trading requested Motion for Reconsideration dated February 15, 2020 and was denied by the Bids and Awards Committee.

**WHEREAS**, the bid proposal of Julimon's Enterprises was found to be substantially complying;
