SINGLE CALCULATED RESPONSIVE BID (LCRB)  
RECOMMENDING AWARD FOR APPROVAL**

**WHEREAS**, the Department of Agriculture advertised the Invitation to Bid for the BID LOT 3- **Supply and Delivery of 1,064 BAGS OPV CORN SEEDS (WHITE)** with IB No. 2020- 004/JJL with an Approved Budget of the Contract of One Million Sixty Four Thousand Pesos (Php1,064,000.00), posted the same in Department of Agriculture website, Phil-GEPS and a conspicuous place of the Department of Agriculture continuously on December 06, 2019 – January 09, 2020;

**WHEREAS**, in response to the said advertisement, **NORTHLAND AGRI- PRODUCTS AND SERVICES** of Kabacan, South Cotabato, and Fareast Hybrid Cooperative of Koronadal City attended the Pre-bid Conference on December 19, 2019, 9:00AM at Harbor Lights Hotel and Restaurant, Gusa, Cagayan de Oro City; while **ARNICHEM, Corp.** of Loz Baños, Laguna did not attend the Prebid Conference;

**WHEREAS**, Opening of Bids was conducted on January 09, 2020, 9:00AM at Chali Beach Resort and Conference Center, Cugman, Cagayan de Oro City, only **NORTHLAND AGRI- PRODUCTS AND SERVICES** of Kabacan, South Cotabato and **ARNICHEM, Corp.** of Loz Baños, Laguna submitted bid proposal on the above mentioned procurement;

**WHEREAS**, **NORTHLAND AGRI- PRODUCTS AND SERVICES** of Kabacan, South Cotabato was declared as **ELIGIBLE AND COMPLYING BIDDER** while **ARNICHEM, Corp.** of Loz Baños, Laguna was declared **INELIGIBLE AND NON-COMPLYING BIDDER** due to attached expired Authority to Print of Official Receipt as supporting document on the SF-GOODS 13b Statement of Single Largest Completed Contracts and failed to attached 2017 ITR payment through EFPS;

**WHEREAS**, the bid proposal of **NORTHLAND AGRI- PRODUCTS AND SERVICES** was found to be substantially complying;


**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:


