**BAC Resolution No. G-0060, series of 2020**

WHEREAS, the Department of Agriculture, Regional Field Office 10 has a Purchase Request for **12605 bundle Cassava Stalk (Planting Material)** with an Approved Budget for the Contract (ABC) of **Four Hundred Fifteen Thousand Nine Hundred Sixty Five Pesos (Php415,965.00)**;

WHEREAS, there is a need to enter into a negotiated procurement under Small Value Procurement considering that the Approved Budget of the contract is **Four Hundred Fifteen Thousand Nine Hundred Sixty Five Pesos (Php415,965.00)** only which is below the threshold level of One Million Pesos (Php1,000,000.00) as provided under Section 53.9 of the revised implementing rules and regulations;

WHEREAS, said Procurement was posted in PhilGeps/Agency website on **February 5 – 10, 2020**;

WHEREAS, **Caraga Farmer's Environmental Developers MPC** of Bayugan City, Agusan del Sur, **Alvins Seedlings Nursery** of Sibagat, Agusan del Sur, **Renel's Fruit Nursery** of Mintal, Davao City responded to the Request for Quotation with the following bid offer/specifications;

WHEREAS, only **Caraga Farmer's Environmental Developers MPC** has found complying to the technical specifications and quoted the lowest price of **Four Hundred Fifteen Thousand Three Hundred Thirty Four Pesos and Seventy Five Cents (Php415,334.75)** which is advantageous to the government and complies with the specifications and other forms and conditions stated in the Request for Quotations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To recommend the award of contract through Negotiated Procurement under Small Value Procurement for **12605 bundle Cassava Stalk (Planting Material)** with price quotation of **Four Hundred Fifteen Thousand Three Hundred Thirty Four Pesos and Seventy Five Cents (Php415,334.75)** to **Caraga Farmer's Environmental Developers MPC** of Bayugan City, Agusan del Sur
