THIS AGREEMENT made this 08 JAN, 2021 day of January, 2021 between the **Department of Agriculture, Regional Field Office 10**, with office address at Antonio Luna Street, Cagayan de Oro City, Philippines, represented herein by its Regional Executive Director, **CARLENE C. COLLADO, CPA**, hereinafter called "the Entity" and **Infinitecare Technology Solutions Inc. (ITSI)**, with office address at J.V. Serina St., Zone 6, Carmen, Cagayan de Oro City, represented herein by its Senior Sales Manager, **RAYMOND C. FERNANDO** hereinafter called "the Supplier";

    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, such as annexes, and all other documents submitted (e.g., Bidder's response to the request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract and the Bidder's conformity thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the**
