WHEREAS, the Department of Agriculture has a Purchase Request for the Supply and delivery of Diesoline and Premium Gasoline for RCUD with an Approved Budget for the Contract (ABC) of One Hundred Seven Thousand One Hundred Pesos (Php107,100.00);

WHEREAS, there is a need to enter into a negotiated procurement under Small Value Procurement considering that the Approved Budget for the contract is One Hundred Seven Thousand One Hundred Pesos (Php107,100.00) only which is below the threshold level of One Million Pesos (Php1,000,000.00) as provided under Section 53.9 of the revised implementing rules and regulations;
