**RESOLUTION NO. A2-0323, SERIES OF 2020
RECOMMENDING THE AWARD THROUGH DIRECT CONTRACTING**

WHEREAS, the Department of Agriculture Regional Field Office 10 (DA RFO 10) has a Purchase Request for the **Provision of Internet Service at the DA Regional Field Office** with an Approved Budget for the Contract (ABC) of **One Hundred Forty Thousand Pesos Only (Php140,000.00)**;

WHEREAS, the Department of Agriculture RFO 10 has an existing Internet Service Provider (ISP) which is the **Parasat Cable TV, Inc.**, with office address at Corrales cor. Ramon Chavez St., Cagayan de Oro City;

WHEREAS, the Department of Agriculture RFO 10 has an existing contract with the internet service provider for the period January to October 2020;

WHEREAS, GPPB Resolution No. 019-2006 issued the approved Guidelines on the Procurement of Water, Electricity, Telecommunications & Internet Service Providers;

WHEREAS, for the procurement of Internet Service Providers, Section 3.3.1 of the Guidelines for Existing ISPs states that: "ISPs provide the initial infrastructure requirements (e.g., cabling) necessary in the provision of internet access. Changing ISPs every year may therefore prove to be costlier to government as every new ISP would have to charge the procuring entity for this initial investment. Further, changing ISPs entails interruption of internet access and, thus, any public service dependent on such access. ";

WHEREAS, **PARASAT Cable TV Inc.** was asked to submit its price quotation and it quoted the following:

WHEREAS, **Parasat Cable TV, Inc.** quoted the amount of **One Hundred Forty Thousand Pesos Only (Php140,000.00)** which remains to be most advantageous to the government and complies with the specifications and other forms and conditions stated in the Approved Purchase Request as per certification from the end-user which also reflects the same rate per month with that of the January to October 2020 Contract;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED;


- a) To recommend the award of contract/renewal of the service agreement between DA RFO 10 and Parasat Cable TV, Inc. for the Provision of Internet Service for the period November to December 2020 at the rate of *Php70,000.00 per month* or a total Contract Price of *One Hundred Forty Thousand Pesos Only (Php140,000.00)*;
- b) To recommend the "AWARD" for the approval of CARLENE C. COLLADO, CPA, Regional Director of the Department of Agriculture Regional Field Office 10 for the forgoing findings.
