BAC Resolution No. G-0085, series of 2020

WHEREAS, the Department of Agriculture, Regional Field Office 10 has a Purchase Request for **Supply and Delivery of 1,559 bags Chicken Manure and 45 bags Organic Fertilizers** with an Approved Budget for the Contract (ABC) of **Four Hundred Four Thousand Six Hundred Pesos (Php404,600.00)**;

WHEREAS, there is a need to enter into a negotiated procurement under Small Value Procurement considering that the Approved Budget of the contract is **Four Hundred Four Thousand Six Hundred Pesos (Php404,600.00)** only which is below the threshold level of One Million Pesos (Php1,000,000.00) as provided under Section 53.9 of the revised implementing rules and regulations;

WHEREAS, said Procurement was posted in PhilGeps/Agency website on **July 7 – 10, 2020**;

WHEREAS, **Roy Agribest Philippines, Inc.** of Silway 7, Polomolok South Cotabato, **Algo Enterprises** of Cagayan de Oro City, **RAJ Agri Business** of General Santos City, responded to the Request for Quotation with the following bid offer/specifications;

WHEREAS, **Algo Enterprises** and **RAJ Agri Business** were declared non-complying due to non-attachment of eligibility documents;

WHEREAS, only **Roy Agribest Philippines, Inc.** has found complying to the technical specifications and quoted the lowest price of **Three Hundred Ninety Six Thousand Five Hundred Eighty Pesos (Php396,580.00)** which is advantageous to the government and complies with the specifications and other forms and conditions stated in the Request for Quotations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To recommend the award of contract through Negotiated Procurement under Small Value Procurement for **Supply and Delivery of 1,559 bags Chicken Manure and 45 bags Organic Fertilizers** with price quotation of **Three Hundred Ninety Six Thousand Five Hundred Eighty Pesos (Php396,580.00)** to **Roy Agribest Philippines, Inc.** of Silway 7, Polomolok South Cotabato
- b) To recommend the award for approval by the Regional Director of the Department of Agriculture RFO10 the foregoing findings


