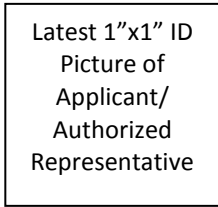

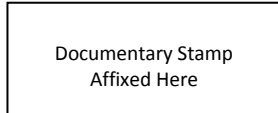

The accomplished form together with all supporting documents shall be filed at the office of the Chief, BAI-AHWD for recording, evaluation, processing and assignment of registration number.

- _____ ID picture of the Owner/General Manager and Veterinarian
- _____ Establishment's/Facility's Veterinarian PRC License, PTR and S2 License from PDEA, if applicable (Photocopy)
- _____ Notarized Employment Contract/MOA of the Veterinarian, when applicable (Photocopy)
- _____ Notarized valid Contract of Lease of the space/building occupied (Photocopy)
- _____ Location Plan/Sketch of the Establishment
- _____ Certification/s that the owner/veterinarian has attended seminar/s on Animal Welfare
- _____ Environmental Clearance Certificate (ECC) from the Department of Environment and Natural Resources (DENR)
- _____ Appropriate permits issued by DENR for wildlife facilities
